Dear Mr. President,

According to the analysis of the Humanistic Outlook Group, provided that

- the national governments of the WHO member states fail to remove from office the members of the World Health Assembly who, by their actions, endanger the sovereignty of their countries and the political authority of their states,
- their new representatives on the to-be-convened Extraordinary World Health Assembly fail to revoke the IHR (2005) Amendment of April 12, 2022,
- the national governments fail to abrogate from the IHR (2005) the feudal right of the WHO Director General to declare a public health emergency of international concern even "if no or very few cases of human illness have yet been detected",
- they likewise fail to reinstate the traditional threshold for notification of an epidemic (5% of the population),
- they also fail to rescind the provocative extension of the public health emergency of international concern and thus the endless pandemic of COVID-19 based on using the "Emergency use ICD codes for COVID-19 disease outbreak " and the "International Guidelines for the Certification and Classification (coding) of COVID-19 as a cause of death",
- and finally, they fail to accept the amendments to the World Health Organization's Constitution and the IHR (2005) proposed by the Humanistic Outlook Group (see the Analytical Note attached to this letter),

in such a case, in the shadow of the endless COVID-19 pandemic, the pandemic of fear and panic, the energy crisis and the war between Russia and Ukraine, the WHO Director General, Mr. Tedros Adhanom Ghebreyesus and the Members of the World Health Assembly will continue the conspiracy against humanity, and, step by step, will seize political power from the leaders of the national governments, the United Nations Organization, the European Union, and as a result he will abolish the sovereignty of most countries of the world, strengthen the dictatorship of the WHO, and impose additional taxes and fees on the citizens of G-20 countries in favour of WHO and its partners.

According to the forecast of the Humanistic Outlook Group, once the IHR Amendment (2005) of April 12, 2022 goes into effect, the following realities will reappear - endless and ineffective quarantine measures, and testing and experimenting with new vaccines on humans instead of on animals, which is a violation of Article 3 of the Nuremberg Code.
